\* \* OUTAGAMIE COUNTY BOARD \* \*

Office of the County Clerk, September 10, 2024.

The Board met pursuant to adjournment, and was called to order by Chairperson Gabrielson at 7:00 p.m. in the County Board Room, located at 320 South Walnut Street, Appleton, Wisconsin.

ROLL CALL: 31 present, 5 absent. The Board Chairperson requested the Board's confirmation to excuse Thompson, Johnson, Croatt, and Hagen. No objections; so ordered.

The Pledge of Allegiance was led by Chairperson Gabrielson.

MINUTES OF THE AUGUST 27, 2024 COUNTY BOARD MEETING

Supervisor Laughtenslager moved, seconded by Supervisor Smith, to approve the minutes of the August 27, 2024 County Board meeting.

ROLL CALL: 30 yes, 1 abstain (Schroeder), 5 absent. MINUTES OF THE AUGUST 27, 2024 COUNTY BOARD MEETING ARE APPROVED.

ESTABLISH ORDER OF THE DAY – Chairperson Gabrielson reported the request to have Resolution No. 51—2024-25 locked in at the meeting.

COMMUNICATIONS –

Chairperson Gabrielson summarized the following communications:

- Rosemary Davis passed away on August 27, 2024, who was an Outagamie County employee for 40 years with the Health and Human Services Department. Chairman Gabrielson touted her accomplishments and praised her passion in bettering the County with her innovation. *The Post-Crescent* featured her obituary; he expressed best wishes to her family.
- Two (2) Supervisors still need to complete cyber security training for May 2024, and nine (9) Supervisors still need to complete the July 2024 training. Chairperson Gabrielson emphasized the importance of completing the trainings, as they are a way to continue to help with remediation and recovery.
- Chairperson Gabrielson reminded the Supervisors about the Oversight Committees folder in their mailboxes, and another version that has been made available in Dropbox as an electronic option.

REPORT BY THE COUNTY EXECUTIVE – County Executive Nelson provided an Administrative update.

NEW BUSINESS

Resolution No. 49—2024-25 – Health and Human Services Committee. Authorize and approve to increase the Community Health Advertising – Promotion line item for \$20,000 in order to correct an error in previously adopted Resolution 4—2024-25, as noted on the attached fiscal note.

Supervisor Cuff moved, seconded by Supervisor McCabe, for adoption.

ROLL CALL: 31 yes, 5 absent. RESOLUTION NO. 49—2024-25 IS ADOPTED.

Resolution No. 50—2024-25 – Health and Human Services Committee. Authorize and approve to transfer the 2024 juvenile transports and mental health client transports budgets from the Health and Human Services Department to the Sheriff's Office, and for the following line items: decrease the Youth Aids Transportation by \$10,000; decrease the Contract Mental Health Transportation by \$55,520.78; and increase the Public Safety Human Services Transports by \$65,520.78, as noted on the attached fiscal note.

Supervisor Patience moved, seconded by Supervisor Kostelny, for adoption.

ROLL CALL: 31 yes, 5 absent. RESOLUTION NO. 50—2024-25 IS ADOPTED.

Resolution No. 51—2024-25 – Property, Airport, Recreation and Economic Development Committee. Authorize the execution of a Warranty Deed to the Wisconsin Department of Transportation for \$5,050 for parcel number 260447400 in Outagamie County, with property interests and rights (as noted on the attachments) and for the line items of Solid Waste for Proceeds from Sale of Asset increase by \$5,050 and Solid Waste Land decrease by \$5,050, as noted on the attached fiscal note.

Supervisor Culbertson moved, seconded by Supervisor Klemp, for adoption.

ROLL CALL: 31 yes, 5 absent. RESOLUTION NO. 51—2024-25 IS ADOPTED.

Resolution No. 52—2024-25 – Property, Airport, Recreation and Economic Development Committee. Approve the Addendum to the Lease Agreement between Outagamie County and Valley Packaging Industries to occupy the county owned premises located at 3375 West Brewster Street, Appleton, until February 1, 2025, as noted on the attached Addendum to Lease Agreement, with no budget adjustment needed at this time, as revenues will be included in the 2025 budget.

Supervisor Monfils moved, seconded by Supervisor Culbertson, for adoption.


ROLL CALL: 31 yes, 5 absent. RESOLUTION NO. 52—2024-25 IS ADOPTED.
