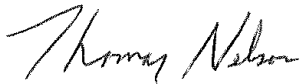
Please be advised of an expired term in the Criminal Justice Coordinating Council (CJCC).

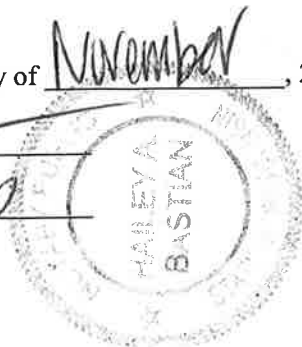
