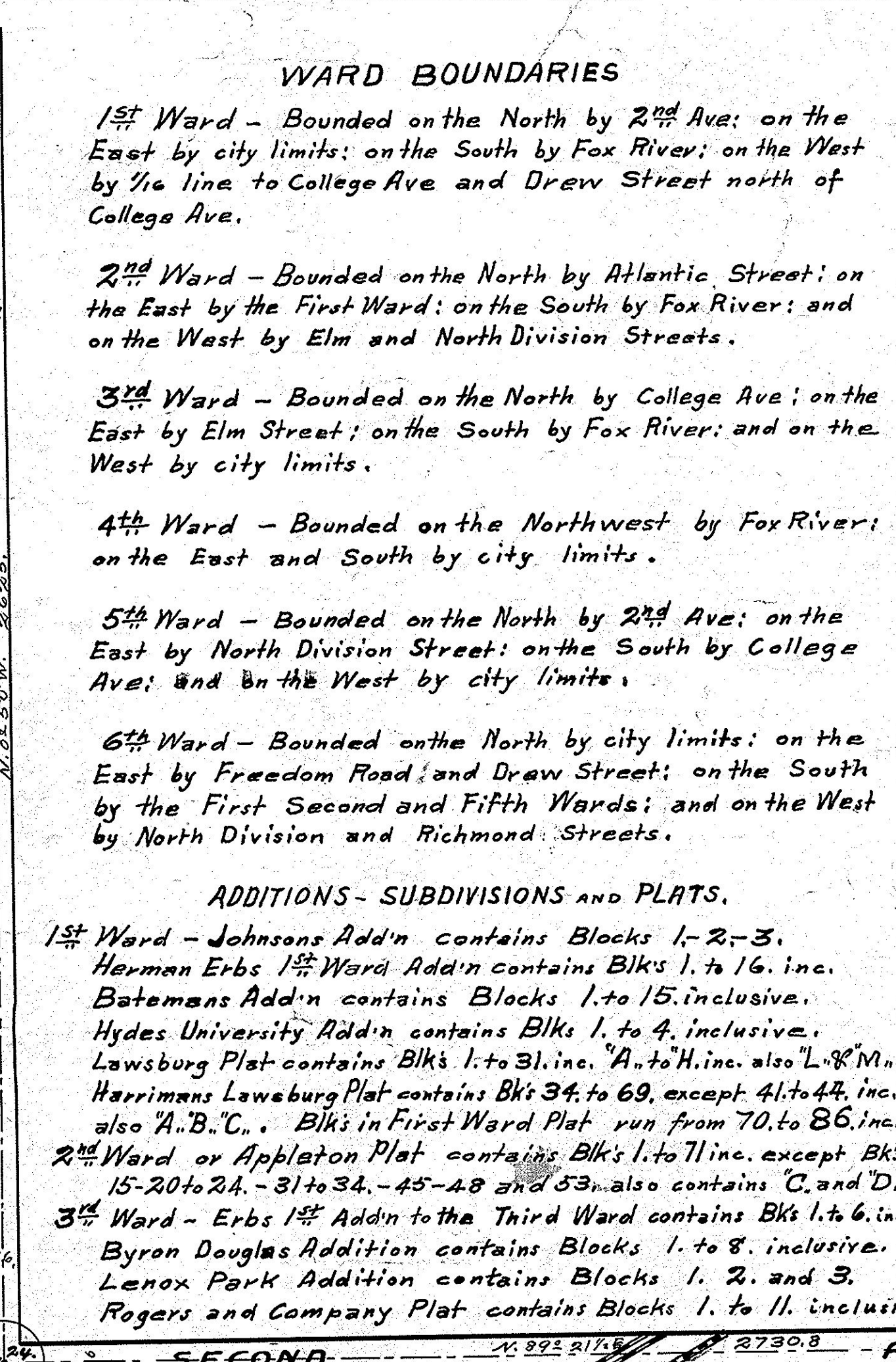




1st Ward - Bounded on the North by 2nd Ave; on the East by city limits; on the South by Fox River; on the West by 1/2 line to College Ave and Drew Street north of College Ave.

2nd Ward - Bounded on the North by Atlantic Street; on the East by the First Ward; on the South by Fox River; and on the West by Elm and North Division Streets.

3rd Ward - Bounded on the North by College Ave; on the East by Elm Street; on the South by Fox River; and on the West by city limits.

4th Ward - Bounded on the Northwest by Fox River;
on the East and South by city limits.

5th Ward - Bounded on the North by 2nd Ave: on the East by North Division Street: on the South by College Ave: and on the West by city limits.

6th Ward - Bounded on the North by city limits; on the East by Freedom Road and Draw Street; on the South by the First Second and Fifth Wards; and on the West by North Division and Richmond Streets.

 Lenox Park Addition contains Blocks 1. 2. and 3.
 Rogers and Company Plat contains Blocks 1. to 11. inclusive.
