Community Health Assessment Background, Framework & Model

BACKGROUND

Local health departments must complete a community health assessment (CHA) every five years. The CHA is a collaborative process conducted in partnership with local organizations and community members. It is an opportunity to learn more about our community, such as: the health of the population, factors that impact health, and community resources available to improve health.

The 2014 community health assessment, Living Well In Outagamie County, is outdated. In the fall of 2019, Outagamie County Public Health (OCPH) began planning for a new CHA process, holding our first CHA Advisory Team meeting on January 16, 2020. The Advisory Team discussed topics including: health equity across population groups, factors that impact our health at the community level, and ideas to communicate the health of the community.

COVID-19 put a hold on the assessment process. In 2021, we are picking up where we left off.

FRAMEWORK & MODEL

The Advisory Team was intentional about focusing on community conditions that impact health, especially among more vulnerable populations. While team members have access to their sector-specific data, they are eager to bring data sets together to increase community awareness and knowledge. As we reviewed CHA frameworks and models, we agreed to pursue a modified approach by combining the more traditional County Health Rankings model with a newer social determinant model.

The County Health Rankings are a set of indicators based on a model of population health that helps communities understand what influences the health of residents in a county.

National Association of City and County Health Officials (NACCHO) developed the guide "Resources for Social Determinants of Health Indicators." The guide is organized into nine domain areas with suggested indicators and how to obtain the data.


By using aspects of both models, the goal is to provide a deeper understanding of all people in Outagamie County in order to make meaningful improvements for everyone's quality of life.


County Health Rankings Model


COMMUNITY PROCESS

Our community process is based on the County Health Rankings Take Action Cycle, a community engagement process offering guidance and tools about HOW to create a healthy community and improve health outcomes.

Step 1 is Assess Needs and Resources. The data in the following pages will help to understand strengths, gaps, needs and resources.

This ongoing process is led by the multidisciplinary OCPH CHA Advisory Team. This team helps to consider new data sources, reviews newly collected data, considers assets and resources, and conducts additional data analysis as needed.

Data Collection Process

DATA COLLECTION PROCESS

The process to collect and compile data included in the CHA involved community partners working together to produce local data sets. OCPH is a member of the Fox Valley Community Health Improvement Coalition (FVCHIC), a collaboration among regional healthcare organizations and local health department jurisdictions to collect community-level data.

QUANTITATIVE PRIMARY DATA

- Outagamie County Community Health Survey - 2018 [Quantitative]
 - Telephone survey modeled on Centers for Disease Control and Prevention's Behavior Risk Factor Surveillance System
- Youth Risk Behavior Survey - 2018 (YRBS) [Quantitative]
 - FVCHIC commissioned an in-depth analysis of high school students in Outagamie County who completed the YRBS
- East Central Wisconsin Regional Planning Commission Survey of Walking and Biking Activity and Attitudes in the Fox Valley Region - 2020 [Qualitative/Quantitative]
 - Survey distributed online and administered using the Qualtrics survey tool. Participant recruitment was conducted by ECWRPC in conjunction with local partners. Participant data included in the analysis came primarily from five counties: Calumet, Outagamie, Waupaca, Waushara and Winnebago.

- Tri-County Community Member and Stakeholder Survey Report - 2018 [Qualitative]

Defining Health & Health Equity

From The HOPE Initiative: Advancing Health Opportunity and Equity Across the United States

The opportunities for good health and well-being vary depending on our race or ethnicity, our level of education and income, where we live and other factors.

Health behaviors like exercise and diet matter a lot, but our behaviors depend on the opportunities and resources we can access.

The good news is that we can create better opportunities for all residents--especially those most vulnerable among us--by expanding health equity. As Braveman (2017) states, "Health equity means that everyone has a fair and just opportunity to be as healthy as possible...measuring the gaps in health and in opportunities for optimal health is important not only to document progress but also to motivate action and indicate the kinds of actions to achieve greater equity."

To expand opportunity, we must first understand where opportunity thrives and for whom, and where we have gaps. We must understand gaps are often a result of historical denial of resources.

The data that follow should be interpreted with an understanding that good health is not only determined by personal choice. Many factors shape differences in health outcomes, include past and current discrimination based on race, ethnicity, national origin, gender, sexual orientation and other identities. 








POPULATION BY AGE





Measuring gaps in education is an important step toward documenting progress in order to achieve greater equity.


Graduation Rates by race/ethnicity 2017-2018


Black and Latino populations have a greater disparity in graduation rates most notably in Outagamie County and Wisconsin compared to the US as a whole





Teen Birth Rate 2012-2018 Outagamie Co


Number of births per 1,000 female population ages 15-19






UNDERSTANDING INCOME




ECONOMIC STRESS

WHO IS ALICE?


A significant portion of full- and part-time workers are paid by the hour; these workers are more likely to have fluctuations in income and less likely to receive benefits. Many "Essential Workers" are ALICE; providing necessary services, yet struggling financially as wages fail to keep pace with household essentials. Data show significant disparities in ALICE status by race and ethnicity (see below).







2-1-1 Top Service Requests in Outagamie Co for 2020











Nitrate naturally occurs in plants and animals and can enter groundwater from fertilizers or animal and human waste.

In WI, nitrate is a common groundwater contaminant.

High nitrate levels are linked with certain birth defects.

Arsenic can naturally occur in soil and rock formations but can also come from pesticides, treated wood, and certain foods. In WI, high levels of arsenic in wells are most common in the northeastern part of the state.

Drinking water with high levels of arsenic can cause skin rashes and stomach problems. Arsenic can also increase the risk for cancer. Infants and children are especially sensitive to arsenic and high levels can affect learning.























Rate per 100,000 alcohol-impaired driving fatalities in Outagamie County




Number of alcohol-related deaths in Outagamie Co
















Adult E-Cigarette Use





% of high school students in Outagamie Co who used an electronic vapor product in the past month































WHO'S AT RISK?

Different demographic groups experience adverse health conditions at differing rates. Here in Outagamie County, as at the national level, the burden of poor health is not distributed evenly.

Health Outcome Disparities in Outagamie County (Primary Quantitative Data)

High Cholesterol



Those 65 and older (44%), with a high school education or less (40%), and who are obese/overweight (29%) are statistically more likely to have high cholesterol.

High Blood Pressure



Those 65 and older (55%), in the bottom 40 percent household income bracket (33%), with a high school education or less (38%), and who are obese/overweight (27%) are statistically more likely to have high blood pressure.

Mental Health Condition



Those who identify as female (27%), age 18-34 (29%), and in the bottom 40 percent household income bracket (28%) are more likely to report a mental health condition.

Those 65 and older (18%) and who are obese/overweight (13%) are more likely to have diabetes.

Diabetes



Those 65 and older (28%), with a high school education or less (12%), and in the bottom 40 percent household income bracket (13%) are more likely to experience heart disease.

Heart Disease



Although there were demographic differences in rates of asthma, there wasn't one group significantly more prone to asthma in the Outagamie County Community Health Survey performed in 2018.

Asthma



Racial and ethnic minorities, LGBTQ+ folks, residents with mental health conditions, and residents who speak English as a second language are all at increased risk for poor health outcomes.





Next Steps: How to improve health

We must examine the complex systems in place that impact our health. The previous pages show the conditions and factors that influence health. In order to improve health outcomes we must first understand the systems in which we live.

Chris Little, deputy director for Systems for Action explains a system approach for improving health.

A strong evidence base confirms what many of us recognize intuitively—multiple systems influence health and must be aligned to improve lives. The fact that health outcomes vary by race and other indicators reflect systemic problems in the medical system. But it also reflects how disparate economic and social circumstances are accounted for. If health care is disconnected from social services or the public health system operates in a silo removed from them both, we're not going to make enough progress.

It's easy to see what this means on the ground. Urging a diabetic to eat nutritious food doesn't mean much if she lives in a food desert. Providing someone else with job training but taking away his subsidized medical care once he is employed is self-defeating. Policies that keep people who have been involved with the criminal justice system out of public housing break the link between a secure home and positive health outcomes.

In short, fragmented systems prevent us from treating the whole person. The research base we are building at Systems for Action helps us understand why we need to do better: **coordinating the delivery and financing of medical care, social services, and public health saves lives.** Drawing on 16 years of data from hundreds of communities across the country, a RWJF-supported study found that **deaths from cardiovascular disease, diabetes, and influenza fall significantly when collaborative mechanisms are in place to promote population health.**

There are many tools to align systems—including integrated financing streams, joint governance bodies, inter-organizational agreements, pooled data, and shared workforce models. But we need to learn more about what works best and get that into wider practice.
