Outagamie County has contracted with CBS Squared, Inc. for the design of improvements to County UU from County J to approximately 300' west of County U in the town of Kaukauna (Outagamie County). The purpose of the project is to replace the existing pavement and rehabilitate the highway to meet current standards by improving pavement condition and drainage on County UU.

The purpose of this letter is to inform you of an upcoming Public Involvement Meeting to discuss the proposed improvements. The meeting will be held at the **Town of Kaukauna Town Hall, W780 Greiner Road, Kaukauna, WI 54130** on **Wednesday, July 15 beginning at 6:00 pm**. A brief presentation will begin at 6:00 pm with the remainder of the meeting following an open house format.

The intent of this meeting is to explain the preliminary design and discuss possible impacts. As stakeholders, your views are important to the design process. The project team is looking for your feedback. At the meeting, please review the preliminary design and share your thoughts either on the comment form provided or with a project team member. Project staff from Outagamie County and CBS Squared will be present to answer your questions. More information regarding the real estate acquisition process will also be shared, with acquisition scheduled to begin in summer of 2026. The project is tentatively scheduled for construction in 2027.
